Art Education Instructor


Educational Qualification

- a) BFA & BVA for the pass out students belonging to visual Art and B.Mus for pass out students belonging to performing Art(the ration of visual Art and performing Art shall be 50:50).
- b) Upper age limit can be relaxed up to 10 years in case of non-availability of candidates .
- c) PH – Ortho / Deaf
- d) The BFA & BVA Art Degree from B,K. College of Art and crafts BBSR, Govt. College of Art & Crafts ,Khalikote and Pvt. Colleges of the state recognized by the state universities may be considered as one of the eligibility criteria for engagement of Art instructors (visual Art).
- e) B.Mus degree from the Utkal sangeet mahavidyalaya and other Govt. & Pvt. Colleges of the state recognized by the state universities may be considered for engagement of Art instructors (performing Art).
- f) The pass out students of V.D. Govt. college of Art and crafts, Jeypore, +2 pass out students of Utkal Sangeet Mahavidyalaya , BBSR, B.K. College of Art & craft, BBSR, Govt. college of Art & crafts, Khalikote may be considered for engagement of Art Instructor.

In case of non availability of candidates of the above qualification, eminent artists who have State Level recognition may be considered for engagement. The district wise list of such candidates shall be provided by Director, Culture.


Local persons (from the same district) may be given priority due to the Part time nature of the job and for easy mobility.

- g) The SCERT being the academic authority shall finalise the syllabus in consultation with B.K. College for Art and crafts, Utkal Sangeet Mahavidyalaya. Culture Directorate to facilitate to provide such curriculum.
- h) OPEPA is the nodal agency to monitor the performance as per the guidelines.






