NOTIFICATION

In pursuance of Section-34(1) of the Right of Children to Free and Compulsory Education (RCFCE) Act, 2009 and in exercise of the powers conferred by the Section-38(1) of the said Act, the State Government do hereby notify the following guidelines regarding functioning of the State Advisory Council constituted /to be constituted under the said Act:

1. The procedure for transaction of Business of the Council shall be as under:
 - (i) The Council shall meet once in three months;
 - (ii) The meeting of the Council shall be presided over by the Chairperson and if for any reason the Chairperson is unable to attend the meeting of the Council, he/ she may nominate a member of the council to preside over such meeting.
 - (iii) Quorum of the meeting of the Council shall be considered complete, if at least 50% of its members (representatives of members excluded) are present.
2. The terms and conditions for appointment of members of the Council shall be as under:
 - (a) Every non official member shall hold office for a term of two years from the date on which he/ she assumes office, provided that no non-official member shall be eligible for nomination for second term.
 - (b) A nominated member may be removed from his/ her office by an order of the Government on the ground of proved misbehaviour or incapacity or on the happening of any one or more of the following events:
 - (i) is adjudged an insolvent;
 - (ii) refuses to act or becomes incapable of acting;
 - (iii) is of unsound mind and stands so declared by a competent Court;
 - (iv) has so abused his office as to render his continuance in office detrimental to the public interest;

(v) is convicted for an offence by a competent Court; or


(vi) is absent from two consecutive meetings of the Council without obtaining leave of absence from the Council;

3. (i) No member shall be removed from his/ her office without being given an adequate opportunity of being heard;

(ii) If vacancy occurs in the office of members, whether by reason of death, resignation or otherwise, such vacancy shall be filled within a period of 120 days by making a fresh appointment in accordance with the provisions of sub-rule 34(1).

4. Payment of allowances (TA/ DA) to the non-official members for attending the meetings will be made as admissible to Group-A officers of Government of Odisha.


