Sub: Procedure for admission against 25% reservations in Private schools under the RTE Act.

Madam/Sir,

As you are aware of under RTE Act "The school specified in sub-clause (iv) of clause (n) of section 2 providing free and compulsory elementary education as specified in clause (c) of section (1) shall be reimbursed expenditure so incurred by it to the extent of per-child-expenditure incurred by the State, or the actual amount charged from the child, whichever is less, in such manner as may be prescribed. In this regard detail modalities have been prepared and enclosed for your reference. However, Finance Department in Govt. has been moved for consideration of the same.

# <u>Procedure of taking of admission under 25% quota in Private schools under the RTE Act (Section-12.1.c), 2009 in Odisha</u>

### A. Determining factors

#### **Children**

- Children belonging to the age group of 6-14 years.
- Out of 25%, 15% seats to be filled up by children belonging to SC, ST, SEBC and Children without any home, settled place, ostensible means of subsistence, found begging, child labour and street child. Out of 15% seats, 10% seats will be reserved for children belonging to SC, ST & SEBC categories and 5% will be reserved for the children belonging to other disadvantaged groups like Children without any home & settled place, ostensible means of subsistence, found begging, child labour, street child & CWSN. Again, 10% meant for SC, ST & SEBC children will be divided among SC, ST & SEBC categories on the basis of their proportion in total population at district level as per the Census 2011.
- Out of 25%, 10% seats to be filled up by children, whose parents are BPL Card holder,

#### Entry level

 25% of the total capacity of the starting class (Pre-primary or class – I) in the school



#### <u>School</u>

- Recognised un-aided & non-minority school starting from pre-primary or class—I,
   having day scholar.
- Aided school upto the extent of such aid.

#### Eligible school for reimbursement

- Recognised un-aided & non-minority school starting from pre-primary or class I
  having day scholar
- Schools having infrastructure and trained human resource as per the schedule of the RTE Act.

#### Non-eligible school for reimbursement

- Govt aided school or any school receives facilities like building/land/any other equipment, free of cost or on concession basis, shall not be entitled for reimbursement to the extent of such obligation.
- Non-recognised schools.
- Schools not fulfilling the infrastructure and HR norm as per the Schedule of the RTE ACT.
- Residential school
- Schools starting with classes higher than class I

## B. Procedure to be followed at different stages

#### Stage - 1

- Circular/notification on the procedure of admission under 25% quota to be issued by the appropriate Govt.
- Creation of awareness among stake holders through advertisement in print &
   electronic media, IEC materials, notification, meetings etc.
- Calculation of per child expenditure and bring it to the notice of the community through notification.
- Capacity building of facilitators (BEO, DEO, DPC etc) for initiating and monitoring the process of admission and reimbursement. RTE cell to facilitate this activity.
- School/Schools (Govt, Aided & Un-aided-recognised) to be attached with the habitation/ward as neighbourhood school. BEO to notify it both for rural and urban area.
- If more than one elementary schools are situated in the neighbourhood (1 KM for primary & 3 KM for UP, relaxed in case of barrier), then all schools will be declared as neighbourhood schools and it is upto the children to take admission in any neighbourhood school as per their choice.
- Calendar of events to be prepared by the RTE cell and approved by DEE, every year.
- Recognition of all Private schools is mandatory. Every three years, it is required to be renewed.

- Per child expenditure to be calculated by the Committee constituted under the Chairpersonship of the SPD, OPEPA.
- Per child expenditure of the previous year to be reimbursed to school in the current year.
- Reimbursement proposal submitted by schools in the current year will be considered in the next financial year.
- Reimbursement will be done to the extent of actual amount charged from the child and per-child-expenditure uncurred by the State Govt per year, whichever is less.
- Reimbursement for pre-primary will be done on the basis of per child expenditure incurred by State Govt divided by two.
- Free seat quota for children belonging to disadvantaged group and weaker section in Govt aided schools = Grants received by the school divided by the total amount of recurring expenditure incurred by the school multiplied by 100.

#### Stage – 2

- Private schools to notify the no. of the seats in class I / pre-primary class every year in the public domain (school display board, Panchayat office etc) and communicate the same to BEO.
- Private school to notify the admission fees to be charged from the child for the particular year.
- Admission to be given to children belonging to disadvantaged group and weaker section groups.



- During admission priority to be given to children belonging to neighbourhood area.
- If there is any surplus seat available, then Private schools will allow children beyond the neighbourhood distance.
- Children are free to apply in any private schools
- Parents are required to apply in a form attached as Annexure 'B' by providing
   all information to the school for seeking admission for their children.
- If there are no children applied or available for taking admission under the 25% quota, then the school will give a self declaration on the no. of seats remain vacant after giving admission to all eligible children and the admission time (July) is over. For filling of the vacant seats, management of the school will apply to the local authority/ BEO and obtain necessary permission.
- Children will be selected through lottery in presence of BEO/representative of BEO, if application no. is more than the no. of seats available under 25% quota in the school.
- Parents will be communicated the date of lottery so that they remain present during the lottery.
- After admission of children under the 25% quota, Private school management to apply to the BEO for reimbursement in the Form No – 'A' with all necessary information.

#### Stage – 3

- BEO to give a rtepor after inspection through field visit.
- BEO to recommend proposal, if it is found eligible after inspection.



- BEO to notify the school wise expenditure in its display board for public information and maintaining transparency.
- BEO to prepare a consolidation sheet (Abstract & school wise information), sign and submit to DEO.
- DEO to prepare a consolidation (Abstract & school wise information) report after taking BEO level reports into consideration with the help of the office of the DPC after matching with the same year DISE. If necessary, DEO would visit some schools on sample basis before the recommendation to DEE.
- After consolidation and necessary scrutiny, DEO will submit the consolidated sheet to the Collector & CEO, ZP for approval.
- After obtaining approval from Collector & CEO, ZP, DEO will send the approved consolidated sheet (Abstract & school wise information) to the Director, Elementary Education.

#### Stage - 4

- After receiving proposals from DEOs, DEE to consolidate in Form No. B and submit the proposal with necessary budgeting and costing to the DSME, GoO for funding provision in the budget.
- After necessary approval from Govt, DSME will place funds to DEE.
- DEE will give required funds to all DEOs.
- DEOs will transfer funds in the shape of reimbursement to school account as provided in the Form No. – A.



#### Stage - 5

- All Private schools will open a separate account for the purpose of depositing funds to be received under 25% quota.
- All schools to keep necessary records for audit and other official purpose.

#### Stage - 6

- State govt to audit the school account regularly.
- All BEOs to monitor the process of admission, attendance & other schooling factors through direct field visit and through ABEO, BRCC & CRCC.
- It is to be ensured that children taking admission under the 25% quota should not be discriminated. Their education rights must be protected.

#### Stage - 7

- Grievance redressal for the purpose will be done by BEO every Monday.
- Director, Elementary Education is the 'Competent Authority' in this regard. DEE
   will also be treated as the 'Appellate Authority' for the purpose.
- Funds required for media activities, IEC materials, printing work, awareness programme, capacity building, training programme, workshop and other things as per the need will be booked under the Project Management, Media & community Mobilisation Head of SSA.
