Terms and Conditions for Printing & Supply of Identity Cards for Teachers and Students of PM-SHRI Schools (2024-25)

 Tender Papers must be submitted in sealed, covered and addressed to the District Project Coordinator, Samagra Shiksha, Subarnapur -767017 by <u>Speed Post/Registered Post/Courier</u> only for printing and supply of Identity Cards for Teachers and Students of PM-SHRI Schools. The sealed envelopes containing the quotation should be superscribed with "Sealed Quotation for printing and supply of Identity Cards for Teachers and Student under PM SHRI Scheme".

Tender papers will be received from 19/07/2025 to 02/08/2025(Up to 5:30 PM) during office hours (except holidays) and will be opened on dated 05/08/2025 at 11.00 AM in the presence of the District Purchase Committee members and the bidders or their authorized representatives, if they desire, for finalisation of bid.

3. Specification of the ID Card: The specification of the ID Card is as follows.

 Durability: Teachers ID Card should last upto 3 years. Guarantee for Letters. Photo. Logos. Printing dual sided Thermal/ Fused PVC card.

Teachers/Students Data (for those ID cards will be made) to be provided by the 08 nos of PM-SHRI Schools under Subarnapur District.

10. The selected bidder needs to visit the concerned school for taking of photograph of students and teacher on his own arrangement. No extra cost will be borne by this office.

 The printed ID card must be delivered at school point as per order given by the undersigned to selected bidder.

12. Order for supply will be placed in bulk as per requirement, which are approximately 4359 (Four Thousand Three Hundred Fifty Nine) nos. of ID Card. The number may be increase/decrease as per actual requirement.

13. Printing must be offset process using eco-friendly ink (I.S.O/I.S.I) standard.

14. The cost of PM SHRI Logo Badge must be inclusive of all taxes and transportation cost to be supplied at school point. No extra cost to be entrained.

15. Others terms and conditions-

- Both EMD & Security deposit are refundable after successful delivery of printing materials. In case of any deviation in terms and conditions, the same will be forfeited.
- The successful bidder has to execute an agreement with the undersigned in nonjudicial stamp paper for printing and supply of ID Card within 3 days of selection of bidder failing which the EMD amount will be forfeited.
- iii. No separate transportation cost to be allowed.
- iv. The bidder must submit the rate in prescribed format enclosed as Annexure-B
- v. TDS will be charged as per the Income Tax and GSTrule.
- vi. The bidder has to submit the copy of GST registration certificate, updated return copy. PAN and latest acknowledgement of income tax returns for the financial year 2023-24, Assessment year 2024-25. Besides the above document, the tender paper submitted without EMD shall not be entertained.
- vii. Conditional tender is not acceptable and will be out rightly rejected.
- viii. Payment will be made in favour of the firm at District point after submission of proof of delivery and after observing formalities of the Tender Call Notice.
