The **DISTRICT PROJECT COORDINATOR, SAMAGRA SHIKSHA, KORAPUT**, on behalf of the Governor of Odisha, invites **Online Percentage rate** tenders through the e-procurement **single** cover system for the construction of work as detailed in the table, from the class of eligible contractors as mentioned in column 4 (four) registered with the State Governments and Contractors of equivalent Grades/Class registered with the Central Government/MES/Railways having a valid license from the appropriate authority for the execution of **Building** works. The proof of registration, from the appropriate authority, shall be enclosed along with the bid. If successful, the bidder who has not registered under the state government has to register under the state PWD in the appropriate class of eligibility before signing the agreement. **All the work is time-bound works for the benefit of people. A penalty as applicable will be imposed for delay in execution of work as per the OPWD Code.** The Bidders may submit bids for the following works.

Terms & Conditions

1. The bid documents are available online and bids are to be submitted online through tendering www.tendersodisha.gov.in. The bidders would be required to register on the website is free of cost. For submission of bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA).
 - a. The bidder must possess Compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
 - b. "Aspiring bidders who have not obtained the user ID and password for participating in e-tendering may obtain the same by registering in the website www.tendersodisha.gov.in. Digital Signature is mandatory in the tendering. Bidders already possessing the digital signature issued from the authorized CAs can use the same in this tender.
 - c. The **Bills of Quantities (BOQ)** shall mention Quantities of each item thereof the Contractor has to mention his **PERCENTAGE RATES*** in figures & words in the prescribed format appended in the Bid document, so that there is no discrepancy, if any discrepancy is found in the percentage quoted in words and figures then percentage quoted by the bidder contractor in words shall be taken as correct. If excess/less is not mentioned, the rate will be treated as excess percentage.
 - d. The Bidder Contractor will write **PERCENTAGE excess or lesser rates** up to two decimal points only. If he writes the **PERCENTAGE** excess or less up to two or more decimal points, the first two decimal points shall only be considered without rounding off.
2. The default maintenance period is one year. Contractor is responsible for any defective work or leakage of slab. Re-construction of defective work or leakage of slab shall be completed by the Bidder Contractor at his own cost.
3. Bids must be accompanied by Earnest Money Deposit/ Bid security (mentioned in page no. 1) of the amount specified for the works and it should be submitted through **on-line mode** specified in www.tendersodisha.gov.in. No **offline** receipt of Tender Paper Cost and **EMD** will be allowed in e-procurement portal of Government of Odisha.
 - a. The officers authorized by the Procurement Officer - Publisher (Officer Inviting Tender) shall transmit the above documents carefully to the Procurement Officer - Publisher prior to opening of bid. The Procurement Officer - Publisher shall provide signed receipt with date and time for having received the number of documents.
 - b. Contractor exempted from payment of EMD will be able to participate in the tender directly by uploading the documentary evidence towards his eligibility for such exemption. The successful bidders will have to deposit bid security @1% of the agreement value during execution of the agreement.
4. Work Experience Certificate of similar nature issued from the Competent Authority with recent date should be submitted for the works whose tender value is above Five Lakhs in **Form-G** as per format in the Tender Document.

5. If the office happens to be closed on the date of opening of the bids as specified, the Bids will be opened on the next working day at the same time and venue. The procedure followed for opening of bid is specified in Guidelines. The lowest bidder will be finalized after evaluating the bids.
6. The bids for the works shall remain valid for acceptance for a period not more than 90 days after the DEADLINE for bid submission.
7. Other details can be had from the bidding documents. The Employer shall not be held liable for any delays due to system failure beyond its control even though the system will attempt to notify the bidders of any bid updates. The Employer shall not be liable for any information not received by the bidder. It is the bidder's responsibility to verify the website for the latest information/ corrigendum related to the bid.
8. Bids shall be received only through "online" on or before 5:30 P.M. on 20.02.2026 along with the scanned documents as per the checklist. If the documents are submitted through hard copies without uploading a scanned copy, which are categorized to be submitted online as per the checklist, they will not be taken into consideration.
9. Tender shall be uploaded in standard formats prescribed in the bid documents displayed at Govt. of Odisha e-Procurement portal and submitted duly filled up. The online bidders should upload the scanned clear copy of the affidavit in support up correctness or proof of the information submitted including bid security accompanied with the tender by them. They should **digitally sign** on all statements and documents; certificates with an affidavit owing genuineness of the documents should also be uploaded. **The affidavit of authenticity of documents uploaded by the bidders being a legal document checking genuineness of signature put on other uploaded documents including affidavit and lease deeds is beyond purview of the officer inviting tender. The bidder himself is liable for the authenticity of the documents if challenged by any other bidder or in the court of law.**
10. The Technical Bid will be opened in the office chamber of the Office of the District Project Coordinator, Samagra Shiksha, Koraput, Odisha, online at 11.30 AM on 21.02.2026 in presence of the bidders / authorized representatives who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will open on the next working day at the day of same time and venue.
11. If any of the intending bidders wish to withdraw from participation in the bid, he/she can freely withdraw from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant Codal practice will be taken against him/her.
12. Any Corrigendum/Addendum will be displayed in the website www.koraput.odisha.gov.in & www.tendersodisha.gov.in only.

13. Amendment of Codal & Contractual Provisions: -

As per the Work Dept. Govt. of Odisha Office Memorandum No. 173/W/2026, Dtd. 03/01/2026 of Principal Secretary to Govt. and EIC-cum-Special Secretary to Govt. of Odisha.

After careful observation, Government has been pleased to abolish the extant provisions of threshold negative bid caps (14.99%) introduced in Appendix-IX, Clause 36 of OPWD Code Volume-II in the procurement of works undertaken by the Govt. of Odisha and its agencies to ensure the procurement process results in a viable and successful manner with adoption of following incremental Additional Performance Security (APS) system:

A. Additional performance security shall be taken on an incremental basis from the selected bidder for low bid prices in the project works as under:

a. where the bid price is below 0% but not below 10% of the project cost put to bid, no additional performance guarantee/security percentage is required.

b. where the bid price is below 10% but not below 20% of the project cost put to bid, the additional performance guarantee/security percentage shall be incremented by 0.1% for every percentage of bid price below 10% of the project cost put to bid starting at 11% with the additional bid performance guarantee being 0.1% and this additional performance guarantee percentage shall be applied on the bid price.



- c. where the bid price is 20% or more below of the project cost put to bid, the additional performance guarantee percentage shall be incremented by 0.2% for every percentage of bid price below 20% of the project cost put to bid in addition to 1% of the bid price and this additional performance guarantee percentage shall be applied on the bid price;
- d. The additional performance guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5% or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.
- e. The additional performance security shall be treated as part of the performance security.
- f. Justification for abnormally low bids shall be scrutinized by the Departmental Technical Committee and recommended to the competent authority of the Administrative Department for the approval of the **Additional Performance Security (APS)**. An abnormally low bid is one in which the Bid price, in combination with other elements of the Bid, appears so low that it raises material concerns as to the capability of the Bidder to perform the contract at the offered price. Procuring Entity may, in such cases, seek written clarifications from the Bidder, including detailed price analyses of its Bid price in relation to scope, schedule, resource mobilization, allocation of risks and responsibilities, and any other requirements of the bid document. If, after evaluating the price analyses, the procuring entity determines that the Bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Procuring Entity may reject the Bid/ Proposal. However, it would not be advisable to fix a normative percentage below the estimated cost, which would automatically be considered as an abnormally low bid.

B. These amendments shall take effect from the date of issue of the O.M.

C. Accordingly, the relevant existing codal/contractual provision stands modified with effect from the date of issue of this O.M.

D. This has been concurred in by the Finance Department vide File No. FIN-WF1-MISC0102-2026.

14. a. The tender accepting authority will verify the originals of all the scanned documents of the lowest successful bidder only within 5 days of opening of the tender. In the eventuality of failure on the part of the lowest bidder to produce the original documents, he will be debarred in future from participating in tender for 3 years and will be blacklisted by the competent authority. In such a situation, successful L-2 bidder will be required to produce his original documents for consideration of his tender at the negotiated rate equal to L-1 bidder.

b. **Scanned clear copies should be uploaded; non-visible copies may be liable for rejection.**

15. In case of SC /ST bidders who want to avail price preference, may avail price preference as per the Resolution File NO. 16262/ W dated. 30.10.2018 of Works Department, Government of Odisha. He / She must have furnished the required affidavit to avail the price preference.

16. When in response to a notice calling for tenders, only a single tender is received the first time Tender shall be cancelled without opening of bid and fresh tender be invited publicly. **If single tender is received, even after retendering, then the approval of the next higher authority should be obtained**, if the tender is otherwise in order and acceptable as per O.M. No.- 16 Dt. 01.01.2015 of Works Department.

17. Engineer Contractor desirous to avail the facility of exemption of EMD is required to submit an affidavit in original to the effect that he/ she has not availed the facility for more than three works during the current financial year. The name of work for which and the authority to whom the tenders have been submitted must be mentioned in the affidavit and he/she should produce his/her original registration certificate at the time of opening of the tender for verification of the license, failing which the tender will be rejected.

18. The bidder shall have to provide their e-mail ID, correspondence address, Mobile no. (WhatsApp) and submit an affidavit in support of authenticity of documents like credential, GSTIN certificate, contractor license, PAN card including the EMD accompanying the bid. The authority reserves the right to verify the authenticity of documents in case any doubt or complaint arises.

19. A bidder can submit only one tender paper for a particular work, submission of more than one tender paper by a bidder for a particular tender will be liable for rejection of all such tender papers as per Works Department letter No. 4985/WE dated. 28.03.2007.

20. The authority will not be held responsible for any technical problem / failure of network, server during the schedule dates on online bidding.

21. Other details can be seen in the Bidding document. The Checklist must be enclosed with the Bid.

22. Conditional tender will summarily be rejected. "The authority reserves the right to reject any or all the tenders without assigning any reason thereof".
