District Project Office, Samagra shiksha, Cuttack invites Expression of Interest(Eoi) from registered Manufacturers/Distributors/Agencies having experience in supplying & installation of standardized furniture for FLN Compliant Class Rooms under STARS Project for the year 2024-25. Interested Parties/Agencies who meet the pre-qualification criteria may download the tender documents from the website and submit the same with a covering letter duly signed by an authorized signatory and a non-refundable cost of bid documents of Rs. 2,000/- (Rupees Two Thousand Only) in the form of a Demand draft or a Pay Order (drawn in favour of Project Coordinator, Samagra shiksha, Cuttack, payable at Cuttack) on or before **19.04.2025** by **5.30 PM** through Speed Post/ Registered Post only to the following address: District Project Office, Samagra shiksha, Collectorate Building, 2nd Floor, Po-Chandini Chowk Cuttack, Pin:- 753002. No other mode of submission will be entertained. All Addendums/Corrigendum's to this notice shall be issued on the above said website.

PRE-QUALIFICATION CRITERIA & TERMS AND CONDITIONS

A. TECHNICAL REQUIREMENTS

1. The applicant should be a well-established specialized agency having experience in supplying & installation of standardized furniture for FLN Compliant Class Rooms or similar related works in reputed Govt. or private institutes.

2. The applicant should have at least 03 years experience in similar nature of work. Experience should be documented in the form of work completion certificate signed by Head of the Institution of the employer or submit payment release letter w.r.t. work order copy. Submission of Work Order in place of experience certificate will not be acceptable.

3. Documents shall not be treated as a valid if not attested at the time of evaluation.

4. The bidders should have applicable Tax registrations (GST, PAN) and other requisite government clearances that are necessary for such work.

5. (a) The firm should have a minimum turnover of Rs.1 Crore during each of the last three financial years. Documentary proof of the same as audited financial statement and IT returns should be submitted.

(b) The firm must have Registered Branch/office or authorised distributor available in Odisha.

6. The bidder/firm should be free from any litigation/ Court cases and should not have been debarred from execution in last three years. An affidavit in this regard should be submitted.

7. All the documents must be duly sealed and signed in each page.

8. The Technical bid and financial bid documents must be submitted separately in ceiled envelope separately .

9. Agencies not fulfilling the minimum eligibility criteria shall be summarily rejected.

10. The District Project Office, Samagra Shiksha, Cuttack can ask for more clarifications, documents, and samples of products (Not mentioned in this EOI) from the bidders as & when required for technical evaluation of credentials of the bidder.

B. OTHER TERMS AND CONDITIONS

1. The proposal and all correspondence and documents shall be written neatly in English without any overwriting.

2. Mode of receipt of tender form:

a) Tender document can be downloaded from the website www.cuttack.odisha.gov.in / www.osepa.odisha.gov.in containing all details of items and terms & conditions. The bidder will submit the non-refundable cost of bid document of Rs 2,000/- (Rupees Two Thousand Only) separately and a refundable bid security of Rs 10,000/- (Ten Thousand only) in the form of bank DD drawn on any nationalized bank payable at Cuttack in the name of District Project Coordinator, Samagra Shiksha, Cuttack.

b) The technical bid of the tenders shall be opened at 3.30 P.M on dated 21st April, 2025 in DPC Conference Hall,Collectorate,Cuttack in presence of Committee

Members and bidders or their authorised representative. Technically qualifying bidders will be invited to demonstrate all prescribed items before the committee members on a specified date to be communicated through official Mail id. On the basis of assessment by the committee, financial Bids of technically qualified bidders whose quality of materials will match as per specification will be opened.

c) The bid shall be submitted in two parts: -

i). **Part I:- TECHNICAL BID** – It will consists of the bidders information, Documents to be submitted indicating the capability, experience as mentioned for eligibility, bid security and cost of bid document as asked as per Annexure. This sealed envelope will be marked as “ PART-A, TECHNICAL BID”.

ii) **Part II: - FINANCIAL BID** – It will contain the price of the tender items. This sealed envelope shall be marked as “ PART-B, FINANCIAL BID”.

iii) The envelope of part-A & part B together shall be sealed in another envelope marked as Eol for supplying & installation of standardized furniture for FLN Compliant Class Rooms.
