The District Project Co-ordinator, Samagra Shiksha, Nayagarh invites bids from the reputed & credible printers / firms/ agencies for printing & supply FLN LAKSHYA and TARGET POSTER ,2022-23 Session. The detailed terms & conditions of the above bid are as under;

### **SCOPE OF WORK AND GENERAL INSTRUCTIONS FOR BIDDERS**

#### **1. Eligibility Criteria :**

The Printers /firms /agencies must have:

- (a) Valid Aadhar /Udyog Registration for printing works.
- (b) Office as well as printing setup in the State of Odisha
- (c) Valid PAN,GSTIN ,VAT Clearance certificate, (self attested with seal Xerox copy).
- (d) Valid GST Registration Certificate.
- (e) GST Return Certificate.
- (f) Sale tax Registration Certificate.
- (g) WEB offset machine with bill copy.
- (h) Self attested copy of Income tax return for last 3 financial year (i.e. 2021-22,2020-21,2019-20)
- (i) One affidavit need to be furnished by the notary that printing firm is not black listed/defaulted in any Govt. organization and keep Secrecy in Question Paper.
- (j) 5 sets of sample papers with TBPM test certificate on GSM with signature and seal of firms be attached in bid document. All original will be verified at the time of opening of tender.

#### **2. Application Procedure:**

- (a) The Bid has been invited under two bid system i.e. **Technical Bid and Financial Bid**. The interested bidders are advised to submit two separate sealed envelopes super scribed as "Technical Bid for Printing & supply of FLN Poster Lakshya & Target & "Financial Bid for printing & Supply of FLN Poster Lakshya & Target". Both sealed envelopes should be kept in another sealed envelope super scribed as "FLN Poster Lakshya & Target".

#### **(b) Technical Bid & Financial Bid.**

The Bidder has to fill up the Technical bid Form (**Tech-1,Tech-2,Tech-3,Tech-04**) & submit it with a separate envelope with all self-attested documents / papers as mentioned in para-2 (f). Similarly, the Financial Bid form has to be filled up as per prescribed form (**Fin-1 & Fin-2**) and to be submitted in a separate sealed envelope. The bidder is to quote **per poster rate** in the prescribed format (FIN-2). The per page rate shall include cost of paper, printing, scanning & planning, DTP, designing, all pre-press expenses, composing, editing, binding, ~~and~~ / CRC- wise / Block- wise packing, all other charges/levies/duties, transportation cost & delivery of the complete material at block point. **Only GST as applicable shall be claimed extra. Accordingly, the bidder has to calculate the per poster rate after taking into account all of the above factors.**

- (c) The tender should be addressed to the District Project Co-ordinator, Samagra Shiksha , Nayagarh, Near DRDA Pin – 752069



- (d) The Bid document is available in website [www.nayagarh.nic.in](http://www.nayagarh.nic.in) / [www.osepa.odisha.gov.in](http://www.osepa.odisha.gov.in) and the cost of the tender paper ( Bid processing fee) is to be enclosed in shape of crossed Demand Draft / banker's Cheque in favour of "District Project Coordinator, SSA Nayagarh" payable at Nayagarh along with the **Technical BID**.
- (e) **Earnest Money Deposit (EMD):** The bidder has to submit EMD amounting to **Rs. 750/-**. The EMD (refundable - without interest), may be submitted in shape of Demand Draft / Banker's cheque/ Bank Guarantee (**Format A**) from any Nationalized or scheduled bank drawn in favour of "District Project Coordinator, SS Nayagarh" payable at Nayagarh, failing which the tender shall be rejected summarily. In case of bank guarantee, it should be valid up to at least 90 days beyond the date of opening of Financial bid. The instrument in original should be necessarily accompanied with the Technical Bid. The EMD of the un-successful bidders shall be refunded within 30 days after award of contract. The EMD shall be forfeited in the event of withdrawal of the tender once submitted OR in case of a successful bidder who (i) fails to execute the agreement within specified period & (ii) not submitted performance security and/or express its inability to supply the finished material within the stipulated period. The EMD of successful bidder shall be refunded after receipt of Performance security. **Exemption** towards EMD and Bid Security shall not be considered.
- (f) The interested Bidders are to enclose self-attested photocopies of the following valid documents /papers in the **Technical Bid envelope**. The proposal submitted without the following documents/papers shall not be considered.

  - Sample papers duly signed & sealed mentioning the GSM as well as name of the manufacturer.
  - Affidavit by Notary that the Firm/Agency is not Black-listed or defaulted for similar type of printing order.

3. The Bidder who meets the requirements specified in the Technical Bid will only be considered for participating in the Financial Bid. Financial Bid of the technically disqualified bidders will not be considered & opened.

#### 4. Submission & opening of Tender:

- (a) The interested Bidders may submit the tender document complete in all respects along with EMD, bid processing fee and other requisite documents **on or before 09.02.2023 for submission of FLN Poster card** addressed to the DPC, SS , Nayagarh only by **registered Post / Speed Post / Courier**. The Authority is not responsible for any postal delay. No other mode of submission of bid shall be entertained.

- (b) **Late Bidders:** Any bid received by the authority after the prescribed time and dateline for submission of bids will not be considered and opened. Thus the same is deemed to be rejected.

- (c) **The Technical bids of FLN Poster card shall be opened on the scheduled date and time at 10.02.2023, 11 AM.** O/o the DPC of the Nayagarh, in the presence of the bidder / their authorized representatives, if any, who wish to be present on the spot at that time.

- (d) The Financial Bid of only those bidders will be opened whose Technical bids are found in order. The date, time & place of opening of Financial BID will be communicated after evaluation of Technical BID.

**6. Evaluation of BID:**

- (a) The Purchase Committee of the District Project Office will evaluate the Technical & Financial BID. The Bidder who meets the requirements specified in the Technical Bid will only be considered for participating in the Financial Bid. Financial Bid of the technically disqualified bidders will not be opened.
- (b) The technically qualified bidder quoting lowest price in the Financial bid shall be considered for award of contract.

**7. Acceptance or Rejection of the Bids:**

- (a) The TIA reserves the right to accept / reject any / all bids / cancel the entire selection process at any stage without assigning any reason thereof. No claim, whatsoever, shall be admissible for the alleged loss/damage suffered by the bidder/s on account of such rejections.
- (b) Any bid with incomplete information is liable for rejection.

**8. Award of Contract :**

The contract will be awarded to the Bidder substantially responsive to the Bid document & offered lowest evaluated cost.

**9. Signing of Contract :**

- (a) The successful bidder/s whose bid has been accepted will sign an agreement with the TIA within 2 days of issue of the work order.
- (b) Failure by the tenderer to comply with the requirement of above mentioned clause, the offer shall be rejected and the tenderer shall have no claim further.

**10. Performance Security Deposit:**

The selected bidder shall have to submit Performance Security Deposit of 5% of contract value in shape of bank draft / Bank Guarantee (BG) drawn on any Nationalized / Scheduled Bank in favour of the "District Project Coordinator, SS Nayagarh" payable at Nayagarh only within 2 days from issue of the work order. In



case of BG , the same shall be as per the **FORMAT-B** & its validity will be at least 30 days from the date of expiry of defect liability period.

**11. Post Delivery Inspection (PDI):**

The TIA shall do the PDI of the quality of paper as well as printing through O/o Text Book Production & Marketing (TBP&M) , Odisha Bhubaneswar .

**12. Requirement & Delivery Schedule :**

The selected firm shall supply the Block wise packets within 15 days from the date of issue of the work order. Approximately( **7616**) numbers of ~~posters~~ are required to be printed for the purpose. The above requirement may increase or decrease as per need. The total cost will be decided on the basis of actual nos. of pages printed & supplied.

15.Only one tender should be submitted by one party. Submission of more than one tender will lead to rejection of all proposal of the bidder.

16.The bidder/s may use separate piece of paper, where the space provided in the formats in this tender document for submission of information, is not sufficient. The information in the separate sheet of paper shall be in prescribed format and its page should be serially numbered and duly authenticated.

17.All the information uploaded & submitted or supplied in the formats of this tender document shall be presumed to be true to the best of the knowledge of the bidder/s.

18.No document as required and mentioned in the Bid shall be submitted in the Technical bid / Financial bid documents unless otherwise specifically mentioned therein. All required documents shall be uploaded with serial number and page mark.

19.The TIA reserves the right to modify any term in the bid document at the time of execution of contract, if felt necessary.

20.The bid validity period is 90 days from the date of opening of the Financial bid. Accordingly the bidder shall submit the Bid.

21.The TIA reserves the right to reject any or all the bids without assigning any reason thereof. The TIA also reserves the right to modify any term in the bid document at the time of execution of contract, if felt necessary.



## **22.Resolution of Disputes:**

- (a) Any dispute between the Tender Inviting Authority and the successful bidder/s should be addressed to the other party only in writing in their respective letter heads signed only by the designated signatories as in contract agreement. Both the parties shall make every effort to resolve the same amicably by mutual consultations.
- (b) If both the parties fail to resolve their dispute or difference by such mutual consultation within twenty-one days of its occurrence, the same will be referred to by either party for conciliation to the conciliation panel. For that purpose, both the parties, shall nominate each one member, and both the nominated members shall form the Conciliation panel. In case the panel members report failure of conciliation, the matter shall be referred to arbitration, by the Arbitrator, to be nominated by the Collector cum Chairman SS Nayagarh. The Collector cum Chairman SS shall nominate an Arbitrator, whenever required or when a request is made by the successful bidder/s, after the failure of conciliation, to nominate an Arbitrator. The arbitration proceeding shall be as per the provisions of the Arbitration and Conciliation Act 1996 of India.

## **23.Applicable Law and Jurisdiction of Courts:**

- (a) The Contract shall be governed by and interpreted in accordance with the existing law of India in force.
- (b) All disputes relating to the contract is subject to the pecuniary jurisdiction of the Court at Nayagarh District.
