

#### ANNEXURE - I

#### ELIGIBILITY CRITERIA

The firm must be registered with respective authorities like GST, as per rules. Copy of Income Tax Return for the last two financial years, i.e. 2021-22 and 2022-23 must be submitted.

- The firm should be in existence for over 3 years in the trade with the resource materials (copy of proof must be attached). Firms having Income Tax Return for 2 years may also participate.
- The office of the firm should be located in Odisha so that immediate replacement of defective materials can be ensured.

# GENERAL INSTRUCTIONS / TERMS AND CONDITIONS

- Procurement of resource materials, which is to be installed at District & Block Resource Centre for the CWSN at Angul, Athamailik, Banarpal, Chhendipada, Kaniha, Kishorenagar, Pallahara & Talcher.
- The interested firm has to submit the tender papers addressed to the DEOcum-District Project Coordinator, Samagra Shiksha, In front of Durga Mandap, 6<sup>th</sup> Lane, Amalapada, Angul — 759122 (Odisha) either by Speed Post / Registered Post/by courier.
- All entries in the tender form should be legible and filled clearly. No underwriting / overwriting are allowed. If the space provided for furnishing information is insufficient, a separate sheet duly signed by the authorized person may be submitted.
- The successful Bidder has to supply and install the resource materials at Block Resource Centre for the CWSN at 8 resource centers of the district.
- 5. The office of the undersigned may procure the materials phase-wise as per requirement. In case, at any point of time, materials received are found defective / not as per quality / specification, the firm will replace the material immediately and in case of failure to do so, the EMD will forfeited and the contract shall be terminated.
- In case the contracting firm is not able to accept the contract after it is awarded or if it is not able to supply the product after accepting the contract, the undersigned will award such contract to the L-2 firm and so on EMD of L1 will be forfeited.
- Any black-listed Firm / Agency shall not be allowed to participate in the tender.

- Any legal dispute is subject to the Civil Courts of Angul, Odisha only.
- The interested bidders have to submit the bid documents in a single master envelope. The bid document should contain the EMD as well as quoted price. The EMD is Rs.24,000/- (Rupees twenty four thousand) only, which will be furnished in shape of Bank Draft in favour of "DPC, SSA, Angul".
- Processing fees non refundable for Rs.1000/- (Rupees one thousand) only which will be furnished in shape of Bank Draft in favour of "<u>DPC, RTE-SSA</u>, <u>Angul, Tribal (General)</u>".
- 11. The EMD of the successful bidder will be converted to performance security and same will be kept for one year. The EMD shall be forfeited, if the firm found to have supplied the goods below the prescribed standards/ specifications. EMD of the unsuccessful bidders shall be returned within 30days of opening of the tender.
