





## TERMS & CONDITIONS

1. The service provider shall have a valid GST registration to participate in the tender process.
2. The vehicle must be on Road worthy condition and shall not be more than **3 years old** from the date of initial Registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Certificate, Valid Contract Carriage permit, proof of up to date tax payment etc. which are mandatory for applying of the vehicle. Preference will be given to new / Latest vehicle.
3. In case of the Firm/ Travel Agency/Individual wish to engage brand new make shall quote the type of vehicle and model against registration.
4. The monthly rate of hire charges (with & without driver) will be quoted separately in the general bid information form **Annexure – A & B** (Excluding fuel and Lubricants).
5. The vehicle must be achieve a fuel efficiency of 10 KM per litre / 17 KM per litre (as applicable) as per Govt. norms.
6. The details of the make and year of manufacture of the vehicle, Registration Number, Mileage, Kilometer covered per liter and period of validity should be specifically provided in the general bid information to be furnished with the Tender (in the form enclosed at **Annexure- A & B** ).
7. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport/passenger vehicle.
8. The Driver should be well behaved, gentle and obedient in nature.
9. A sum of Rs.10,000/- ( Rupees Ten Thousand) only shall be deposited by the intending bidder in shape of Account Payee Bank Draft drawn in favour of the “**District Project Coordinator, Samagra Shiksha, Balangir**” and submitted along with the tender as EMD. After completion of tender process, EMD shall be refunded to unsuccessful bidders.
10. The maximum permissible hire charges per month, excluding fuel cost and GST is Rs. 24000/- (Rupees Twenty Four Thousand) only as per OSEPA norms.
11. The types of vehicle (**without Driver**) allowed are preferably Bolero – NEO/TUV-300/ Scorpio or any other higher make model vehicle, preferably a **BS-VI compliant diesel vehicle**.
12. The types of vehicle (**with Driver**) allowed are preferably Swift/ Swift Dezire/ Tata Zest/ Tata Tiago or any other higher make model vehicle, preferably a **BS-VI compliant Petrol vehicle**.

15. The successful bidder has to furnish performance security of an amount of **Rs.5000/- (Five thousand)** in shape of account payee Bank draft drawn in favour of the "**District Project Coordinator, Samagra Shiksha, Balangir**" within three days from the date of the receipt of acceptance letter .
16. The Selected Bidder will have to sign an Agreement with the undersigned for execution of supply of vehicle to DPO,SS, Balangir.
17. It shall be the responsibility of the bidder to provide a good driver and the remuneration of the driver shall be borne by the service provider.
18. The vehicles shall be kept at the disposal of the undersigned throughout the Agreement period.
19. In case of emergency, the driver will have to report for duty as per the requirement. No extra payment shall be made for the purpose.
