The District Project Coordinator, Samagra Shiksha Cuttack invite bids from the reputed & credible, authorized suppliers / firms/ agencies for supply of Teaching learning Materials for the students of Sishu Vatika to Grade III. The detailed terms & conditions of the above bid are as under;

SCOPE OF WORK AND GENERAL INSTRUCTIONS FOR BIDDERS

1. Eligibility Criteria :

The Suppliers/firms /agencies must have:

- (a) Valid Aadhar Udyog / Udyam Registration Certificate
- (b) Proof of Office setup in the State of Odisha
- (c) Valid PAN
- (d) Valid GST Registration under Odisha GST (OGST) Act with up to date filing acknowledgement.
- (e) Production Certificate of DIC
- (f) Bid Specific OEM Authorization
- (g) Average turnover of Rs. 3.00 Crore(Three Crore) in last 3 financial year

2. Application Procedure:

- (a) The Bid has been invited under two bid system i.e. **Technical Bid and Financial Bid**. The interested bidders are advised to submit two separate sealed envelopes super scribed “Technical Bid for Procurement of Teaching Learning Materials,2025-26 & “Financial Bid for Procurement of Teaching Learning Materials,2025-26” .Both sealed envelopes should be kept in another sealed envelope super scribed “Tender for Procurement of Teaching Learning Materials,2025-26”.

(b) Technical Bid & Financial Bid.

The Bidder has to fill up the Technical bid Form (**Tech-1,Tech-2,Tech-3,Tech-4**) & submit it within a separate envelope with all self-attested documents / papers as mentioned in para-2 (f) .Similarity, the Financial Bid form has to be filled up as per prescribed form (**Fin-1 & Fin-2**) and to be submitted in separate sealed envelope. The bidder is to quote **rate per set per child** in the prescribed format (FIN-2). The rate shall include all cost inclusive of Tax, all other charges/levies/duties, transportation cost & delivery of the complete material at block point. No additional cost over & above the quoted rate will be entertained. **Accordingly, the bidder has to quote rate per set after taking into account all of the above items prescribed for Grade- Sishu Vatika & Grade I,II ,III**



separately. All materials must be of a reputed brand. Only one price should be quoted for set.

- (c) The tender should be addressed to **District project Office, Samagra Siksha , Cuttack, At-Collectorate Building, Po –Chandini Chowk, Dist-Cuttack, PIN-753002**
- (d) The Bid document shall be available in website <https://cuttack.odisha.gov.in> / www.osepa.odisha.gov.in and the cost of the tender paper is to be enclosed in shape of crossed Demand Draft / banker's Cheque in favour of "District Project Office, Samagra Shiksha, Cuttack" payable at Cuttack along with the **Technical BID**.
- (e) **Earnest Money Deposit (EMD):** The bidder is to submit EMD amounting to **Rs.140000/-(Rupees One Lakh forty Thousand) only**. The EMD (refundable - without interest), may be submitted in shape of Demand Draft / Banker's cheque/ Bank Guarantee (**Format A**) from any Nationalized or scheduled bank drawn in favour of "District Project Office, Samagra Shiksha, Cuttack" payable at Cuttack, failing which the tender shall be rejected summarily. In case of bank guarantee, it should be valid up to at least 90 days beyond the date of opening of Financial bid. The instrument in original should be necessarily accompanied with the Technical Bid. The EMD of the un-successful bidders shall be refunded within 30 days after award of contract. The EMD shall be forfeited in the event of withdrawal of the tender once submitted OR in case of a successful bidder who (i) fails to execute the agreement within specified period & (ii) not submitted performance security and/or express its inability to supply the finished material within the stipulated period. The EMD of successful bidder shall be refunded after receipt of Performance security. **Exemption** towards EMD and Performance Security shall not be considered.
- (f) The interested Bidders are to enclose self-attested photocopies of the following valid documents / papers in the **Technical Bid envelope**. The proposal submitted without the following documents/papers shall not be considered.
 - (a) Valid Aadhar Udyog / Udyam Registration certificate for supply of Materials.
 - (b) Valid Bid Specific OEM Authorization
 - (c) valid PAN
 - (d) Valid GST Registration Certificate under Odisha GST (OGST) Act with upto date GST filling acknowledgement till March, 2025.
 - (e) Production Certificate of DIC
 - (f) DD/Bankers Cheque amounting to Rs.2000/-only as bid processing fee.
 - (g) EMD in shape of Demand Draft / Bankers Cheque / Bank Guarantee
 - (h) Income Tax Return for the Financial Year 2021-22,2022-23 & 2023-24 i.e. Assessment Year 2022-23 , 2023-24 & 2024-25.



- (i) Bidder must have to submit samples with tender documents. All materials must be of a reputed brand.
 - (j) Turnover- The bidder should have average annual turnover of **Rs. 03.00 crore** (Rupees Three Crore) only during last three financial years. Proof to be submitted by the bidder in form of audited balance sheet, income & expenditure statement and profit& loss account from a Chartered Accountant).
 - (k) Audited Balance sheet of last 03 years
 - (l) Duly filled in, signed & sealed Tech-1,Tech-2,Tech-3 & Tech-4 formats.
 - (m) One year Experience regarding supply of similar type of items
 - (n) Affidavit by the Notary as regards to non-black listing of the agency in similar type of work.
3. The Bidder who meets the requirements specified in the Technical Bid will only be considered for participating in the Financial Bid. Financial Bid of the technically disqualified bidders will not be considered & opened.
4. **Submission & opening of Tender:**
- (a) The interested Bidders may submit the tender document complete in all respects along with EMD, bid processing fee and other requisite documents on or before 13.5.2025 by 5.30 PM. (in all working days) addressed to undersigned address mentioned above through Speed Post / Registered Post / Courier only. The Authority is not responsible for any delay. No other mode of submission of bid shall be entertained.
 - (b) **Late Bidders:** Any bid received by the authority after the prescribed time and dateline for submission of bids will not be considered and opened. Thus the same is deemed to be rejected.
 - (c) The Technical bids shall be opened on the scheduled date and time at **DPO, Samagra Shiksha(VC Room)** in Collectorate Building, Cuttack in the presence of the bidders/ their authorized representatives, if any, who wish to be present on the spot at that time.
 - (d) The Financial Bid of only those bidders will be opened whose Technical bids are found in order. The date, time& place of opening of Financial BID will be communicated after evaluation of Technical BID.
5. **Specifications :** Detail specification of the items (as specified by State Office) is mentioned at **Annexure- X**.
6. The tender should be addressed to **Samagra Siksha , Cuttack, At-Collectorate Building, Po –Chandini Chowk, Dist-Cuttack, PIN-753002**
7. **Evaluation of BID:**
- (a) The Purchase Committee of the District Project Office, Samagra Shiksha, Cuttack will evaluate the Technical & Financial BID. The Bidder who meets the requirements specified in the Technical Bid will only be



- considered for participating in the Financial Bid. Financial Bid of the technically disqualified bidders will not be opened.
- (b) The technical committee of DEO-Cum-DPC, Samagra Shiksha, Cuttack will verify the sample material & impelled bidders according to the quality of sample material.
 - (c) The sample material qualified bidders quoting lowest price in the Financial bid shall be considered for award of contract.
 - (d) The decision of the committee is final & bound to be accepted by the bidders.

8. Acceptance or Rejection of the Bids:

- (a) The TIA reserves the right to accept / reject any / all bids / cancel the entire selection process at any stage without assigning any reason thereof. No claim, whatsoever, shall be admissible for the alleged loss/damage suffered by the bidder/s on account of such rejections.
- (b) Any bid with incomplete information is liable for rejection.

9. Award of Contract :

The contract will be awarded to the Bidder/s substantially responsive to the Bid document & offered lowest evaluated cost.

10. Signing of Contract :

- (a) The successful bidder/s whose bid has been accepted will sign an agreement with the TIA immediately after issue of intimation for bid acceptance. Price of the selected bidders will be valid for 1 year.
- (b) Failure by the tenderer to comply with the requirement of above mentioned clause, the offer shall be rejected and the tenderer shall have no claim further.

11. Performance Security Deposit:

The selected bidder shall have to submit Performance Security Deposit of 05% of contract value in shape of bank draft / Bank Guarantee (BG) drawn on any Nationalized / Scheduled Bank in favour of the "District Project Office, Samagra Shiksha, Cuttack" payable at Cuttack only within 24 hours from issue of bid acceptance letter. In case of BG, the same shall be as per the **FORMAT-B** & its validity will be at least 30 days from the date of expiry of defect liability period.

12. Post Delivery Inspection (PDI):

The TIA shall do the PDI of the quality of materials by the district level committee.

13. Requirement & Delivery Schedule :

The selected supplier shall supply the TLMs materials packeting , School wise, cluster wise & Block wise on or before 5.6.2025. The class wise requirements are as below. The above requirement may increase or decrease as per need. The total cost will be decided on the basis of actual nos. of TLM supplied.

14. Payment terms:

On completion of delivery at Block point: the selected bidder will have to submit the following document for release of payment

- a. Challans towards satisfactory completion of supply of quantity to concerned block point as per supply order.
- b. Receipt of "receive & stock entry certificate" from concerned BEO.
- c. Four self-inking carbon copies of the GSTIN invoice as well as bank details for payment purpose.
- d. PDI report from technical committee.
- e. IT-TDS & GST-TDS will be deducted as per the prevailing rate.

No advance payment shall be made, or no payment shall be entertained on negotiation through Bank.

15. Penalty :

- (a) If the work is delayed for any reason for which the TIA is not responsible, penalty @ 0.5 % per week or part thereof on the total cost maximum up to 10% of the contract value will be imposed on the firm under orders of appropriate Authority. The TIA reserves the right to forfeit the Performance Security & debar the bidder from participating in any other bid of his/her office. In such cases the TIA may write Govt. for blacklisting the firm.
- (b) If the Post Delivery Inspection of the quality of materials shows negative results, then penalty will be imposed proportionately on the total cost after deduction of tolerance limit prescribed by Govt., if any.
- (c) If the quality of materials is found to be dissatisfactory, penalty as suggested by the purchase committee will be imposed.

16. Amendments to BID terms ,conditions and issue of Corrigendum/addendum:

- (a) The TIA may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder/s, modify the Bidding Documents by amendment /corrigendum.
- (b) The amendment in shape of corrigendum/addendum will be notified on the websites <https://cuttack.odisha.gov.in/> www.osepa.odisha.gov.in and the prospective bidder/s are requested to take cognizance of such notification/s while submitting their tender proposal.
- (c) In order to allow prospective Bidder/s reasonable time in which to take the amendment into account in preparing their bid, the TIA may, at its discretion, extend the deadline for the submission of bids.

17. Only one tender should be submitted by one party. Submission of more than one tender will lead to rejection of all proposal of the bidder.



18. The bidder/s may use separate piece of paper, where the space provided in the formats in this tender document for submission of information, is not sufficient. The information in the separate sheet of paper shall be in prescribed format and its page should be serially numbered and duly authenticated.
19. All the information uploaded & submitted or supplied in the formats of this tender document shall be presumed to be true to the best of the knowledge of the bidder/s.
20. No document as required and mentioned in the Bid shall be submitted in the Technical bid / Financial bid documents unless otherwise specifically mentioned therein. All required documents shall be uploaded with serial number and page mark.
21. The TIA reserves the right to modify any term in the bid document at the time of execution of contract, if felt necessary.
22. The bid validity period is 90 days from the date of opening of the financial bid. Accordingly the bidder shall submit the Bid.
23. The TIA reserves the right to reject any or all the bids without assigning any reason thereof. The TIA also reserves the right to modify any term in the bid document at the time of execution of contract, if felt necessary.
24. **Resolution of Disputes:**
 - (a) Any dispute between the Tender Inviting Authority and the successful bidder/s should be addressed to the other party only in writing in their respective letter heads signed only by the designated signatories as in contract agreement. Both the parties shall make every effort to resolve the same amicably by mutual consultations.
 - (b) If both the parties fail to resolve their dispute or difference by such mutual consultation within twenty-one days of its occurrence, the same will be referred to by either party for conciliation to the conciliation panel. For that purpose, both the parties, shall nominate each one member, and both the nominated members shall form the Conciliation panel. In case the panel members report failure of conciliation, the matter shall be referred to arbitration, by the Arbitrator, to be nominated by the Collector-cum-Chairman, SS, Cuttack. The Collector-cum- Chairman, SS, Cuttack shall nominate an Arbitrator, whenever required or when a request is made by the successful bidder/s, after the failure of conciliation, to nominate an Arbitrator. The arbitration proceeding shall be as per the provisions of the Arbitration and Conciliation Act 1996 of India.
25. **Applicable Law and Jurisdiction of Courts:**
 - (a) The Contract shall be governed by and interpreted in accordance with the existing law of India in force.
 - (b) All disputes relating to the contract is subject to the pecuniary jurisdiction of the Court at Cuttack, Odisha

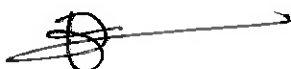
