#### ANNEXURE - I

#### **ELIGIBILITY CRITERIA**

- 1. The firm must have valid PAN.
- The firm must be registered with respective authorities like GST and valid GSTN as per rules.
- Copy of Income Tax Return for the last two financial years, i.e. 2024-25 and 2025-26 must be submitted.
- The firm should be in existence for over 2 years in the trade with Power Spectacles for students with vision problems (copy of proof must be attached).
- The firm must have annual turnover of Rs.3,00,000.00 (Rupees three lakhs) or above.
- The office of the firm should be located in Odisha so that immediate replacement of defective materials can be ensured.

# GENERAL INSTRUCTIONS / TERMS AND CONDITIONS

- The intending bidders have to furnish nonrefundable processing fees for Rs.1000/-(Rupees one thousand) only in shape of Bank Draft favouring account "<u>DPC</u>, <u>RTE-SSA</u>, <u>Angul</u>, <u>Tribal</u> (General)".
- Participant bidders have to submit the bid documents in a single master envelope and bid documents must contain one EMD (refundable) for Rs.30,000/- (Rupees thirty thousand) only in shape of Bank Draft favouring "the account "DPC, RTE-SSA, Angul, Tribal (General)"
- The EMD of the successful bidder will be converted to performance security and same will be kept for one year. The EMDs of the unsuccessful bidders shall be returned within 30-days of opening of the tender.
- The interested firm has to submit the tender papers addressed to the DEO-cum-District
   Project Coordinator, Samagra Shiksha, In front of Durga Mandap, 6<sup>th</sup> Lane,

   Amalapada, Angul 759122 (Odisha) either by Speed Post / Registered Post/by courier or Tender drop box kept at office.
- All entries in the tender form should be legible and filled clearly. No underwriting / overwriting are allowed. If the space provided for furnishing information is insufficient, a separate sheet duly signed by the authorized person may be submitted.
- The successful Bidder has to sign an agreement with the undersigned regarding the supply of power spectacles at the camp site as per his own cost as per terms and conditions.
- The bidder/bidders must have Auto-Refractometer for computerized eye testing at the camp site.
- The bidder/bidders must have Mini Vision Box (testing provision of 3 meters or 10 feet's) with uninterrupted power supply at the camp site.
- The bidder/bidders must have trial set along with related eye testing provisions at the camp site.
- 10. The bidder/bidders must have Electric Power Generator having capacity to function all his machines to prepare spectacles at the time of power cut at the camp site.
- 11. The bidder/bidders must have sufficient skilled manpower having capacity to prepare and deliver at least 250 power spectacles during the camp time in a day.



- 12. The bidder/bidders must have lenso-meter for measurement of lens power and cross verification power lenses as and when required at the camp site.
- 13. The bidder/bidders must have own vehicles for transportation of his manpower, machines and related equipment to the camp site before 30 minutes of scheduled camp time for prior arrangement at their own cost and responsibility.
- 14. The bidder/bidders must have capacity to deliver power spectacles covering variety colours of frames and powers as per the need of the beneficiary students at the camp site.
- 15. All lenses must be in fiber and spectacles frames must have different attractive colour made with durable plastic.
- 16. Rate must be including all taxes not exceeding Rs.300/-(Rupees Three Hundred) only.
- 17. The bidder/bidders must have to provide follow up services if required (include repair and maintenance) throughout the year without any extra charge.
- 18. In case, at any point of time, power spectacles found defective / not as per quality / specification, the EMD of the firm will be forfeited and the contract shall be terminated.
- In case the successful firm is not able to supply the power spectacles, the undersigned will award such contract to the L-2 firm and so on EMD of L1 will be forfeited.
- 20. Any black-listed Firms / Agency shall not be allowed to participate in the tender.
- 21. Any legal dispute is subject to the Civil Courts of Angul, Odisha only.
- Incomplete data or conditional bid documents to be rejected out rightly and also partly quoted bids will not be considered.
- 23. The quoted price of financial bid must be included all taxes along with making and delivery at the camp site.
- 24. The bid will remain valid up to 90 days from the date of finalization.
- 25. TDS will be deducted as per prevailing law.
- The undersigned reserves the right to accept or reject any tender without assigning any reason thereof.
